Payment:

Rental equipment requires a fifty dollar deposit and the final balance must be paid upon delivery or pick up, Tents are 50% Deposit. Cancellations must be must within 48 hours notice. (Bad weather cancellations, severe storms, heavy snow, ice or wind can be cancelled by 9am the morning of the rental) Deposits are non-refundable but will be applied as a credit against your next rental for up to one year.

Items are dropped off/picked up the morning of the event and will be picked/returned that evening, unless other arrangements are made in advance. Equipment is not set-up or broke down by Extreme Parties. Tables and chairs must be "broke down" for pick up.

Limits of Liability on Rental of Equipment:

Extreme Parties will not be responsible for damage done as a result of using any of our rental equipment. The customer agrees he/she is solely responsible for all damages and liability arising out of the use of the rental equipment. The customer agrees to operate and/or use rental equipment only in a reasonable manner and consistent with the use for which the rental equipment was designed. Rental equipment is not to get wet or left in the weather.

Additional Provisions of Rental Equipment:

The customer agrees to operate the equipment as directed. If you have questions you should stop use and call Extreme parties for further directions. Only the customer is to operate the equipment and agrees not to transfer the equipment to others. The equipment must stay in the signed customers care at all times. The custom is responsible for the equipment and is liable for its misuse, loss, damage or theft. The customer hereby acknowledges that they have sufficient homeowner's tenant or other liability insurance. We reserve the right the remove our equipment without refund or notice in the case of gross misconduct.

Electricity may be required for select rental equipment, this is the customer responsibility.

(Recommended no further than 100 foot.)Do not clean concessions with cleaning products use only warm water to wipe off rental equipment. Renter will inform of any water sprinklers, underground wiring, water lines etc, prior to setting up tents, ground must be level and free of overhead obstructions, tents must have minimum of 5 Foot clearance around outside of tent.

Extreme Parties will clean the equipment. Some cleaning solutions can damage the concessions.

No other products should be used with the concessions; examples include other popcorn brands or cotton candy floss. These items are included in your rental if additional quantities are needed you can purchase them directly from us.

Anything can be dangerous if used improperly or carelessly. We have tried to instruct you, our client, in the proper use of our equipment. We can not always be present to protect you so please protect yourself and be careful.
